#### **Revised Order**

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- 2. And whereas, the Rashtriya Sanskrit Sansthan Deemed University, Plot No. 291/76, 292/76, 320/44, 45, 75/2, SKT Marg, Village-Bagsevania, Post Office-Laharpur, Tehsil/Taluka: Huzoor, Towh/City: Bhopal, Dist-Bhopal-462043, Madhya Pradesh by affidavit dt. 21.01.2015 has consented to come under new Regulations and sought for one unit of 50 seats in M.Ed., which require additional facilities.
- 3. And whereas, it has been decided to permit the institution to have one unit of 50 seats subject to the institution fulfilling following conditions namely.
  - 1. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
  - 11. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
  - III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 leb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
  - IV. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt, and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.
  - 4. Now therefore, in the light of the above and in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) hereby issues the revised recognition order to Rashtriya Sanskrit Sansthan Deemed University, Plot No. 291/76, 292/76, 320/44, 45, 75/2, SKT Marg, Village-Bagsevania, Post Office-Laharpur, Tehsil/Taluka: Huzoor, Town/City: Bhopal, Dist-Bhopal-462043, Madhya Pradesh for conducting M.Ed programme of two years duration with an annual intake of 50 students (one unit) from the academic session 2015-16 subject to fulfillment of the conditions mentioned herein before 31.10.2015.
  - 5. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.



- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
- The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

Sanctioned programmes along with annual intake in the institution:

Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

Name of faculty members who left or joined during the last, quarter:

Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

Fee charged from students;

Available infrastructural facilities:

Facilities added during the last quarter;

Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

The affidavit with enclosure submitted along with application.

- The institution shall be free to post additional relevant information, if it so desires.
- Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

Recognition order no. WRC/WRCAPP1458/181/MP/2012/102287-92 dt. 25/04/2013 be treated as cancelled from the date of issue of this revised order.

Rashtriya Sanskrit Sansthan, New Delhi (RSKS), a deemed university under the Ministry of Human Resource Development, is recognised by the University Grants Commission (UGC) and has been accredited by National Assessment and Accreditation Council (NAAC) with 'A' Grade. RSKS was established in the year 1970 by the Government of India to preserve, promote and propagate the learning of traditional Sanskrit in India and abroad. RSKS has been declared as Deemed to be University vide Government of India & UGC Notification No. F.9-28/2000-U.3 dt. 7.5.2002 and F.6.31/2001 (CPP-I) dt. 13.6.2002 respectively. RSKS is fully funded by Govt. of India.

2. RSKS conducts the examinations from Prathama (8th Standard) to Acharya (M.A) level and also conducts Ph.D. programmes. RSKS has 10 campuses spread across the country and also have a number of institutes affiliated to it. RSKS conducts traditional Sanskrit examinations for the students in these institutes, in a centralised manner at New Delhi. The certificates/degrees awarded by RSKS are equivalent to the modern certificates/degrees awarded by other Universities/Boards/Examining Bodies situated in the country as under: —
